Round Table Discussion

Topic: Communication Between School and Home and Home and School – Sharon C.

Discussed the channels of communication available to parents / guardians. Families are encouraged to contact their child's teacher as a first point of contact. The School admin team is accessible if there is a matter to be escalated or an issue left unresolved, but admin will confirm with the family that the teacher has been contacted first.

Issues discussed over social media can and have been screen shot and provided to school administration. If there is an issue to be dealt with, families are encouraged to discuss directly with the school.

How do we as a council communicate with RancheView Community? – Fiona G.

Feedback from parents on Student Led Showcases (SLS) is that it would be easier to communicate with teachers when a date and time is set. At the first SLS last school year there were some families who did not have the ability to ask questions. – Stacey F.

There are also instances of families not being able to get one on one time with the teacher due to other families monopolizing the teacher's time. – Rochelle S.

If a 10 minute chat was set you could speak directly with the teacher to discuss any concerns. The current set up could have your own children as well as other families around during the conversation, which may not be ideal. – Jen H.

Teachers are meant to be a "centre" in the classroom SLS, however some teachers have opted to mill about the room instead but will make it clear that they will commit to speaking with everyone. Sharon will continue to have conversations with teachers regarding how they choose to structure their SLS.

Teachers are open to ongoing communication with families. There could potentially be appointments after school hours at the discretion of the teacher, and this does occur regularly. Consideration does however need to be given on both sides. If there are any issues or concerns the expectation is the teacher and family have discussed either by phone, email, or appointment, prior to SLS. SLS are a means to empower children to showcase their work and allows them to be a part of the discussion. This helps to encourage positive home / school relations. — Sharon C.

Do we find value in the weekly highlights and newsletter? – Fiona G.

Collectively everyone in the room appreciates the communication received from the school. Some teachers also send a weekly email. Sharon will discuss consistency among grade teams with the teachers.

Trustee Report - Fiona G.

School Board Elections

RVS' 2017-2021 Board of Trustees is now set. At the close of Election Day, Oct. 16, the following trustees were elected in:

Ward 1 - Shali Baziuk

Ward 5 – Judi Hunter

These individuals will join Trustees acclaimed in Ward 2 – Patty Sproule, Ward 4 – Norma Lang, and Ward 6 – Fiona Gilbert, to form RVS' governing body for the next four years. Congratulations to all! The official swearing-in ceremony will take place Oct. 24, with the first regular meeting of the new Board of Trustees scheduled for Nov. 2, 2017.

Capital Plan Revision

Alberta Education will consider revisions of board's 2018-2021 Capital plan priorities if submitted before Oct. 15, 2017. Based on the fact that new school construction funding will be provided to school jurisdictions only if the requirements of accommodation needs and site readiness are met, RVS will submit a revised Capital Plan. In the current Capital Plan, the six new school construction priorities meet only the accommodation need, not the site readiness requirement. At this time, there is only one priority from the first budget year – Langdon Junior/Senior High School – that meets both requirements. At the Oct. 5 Board meeting, Trustees approved a revised Capital Plan submission, moving the Langdon Junior/High School to the #1 priority, with a request for design funding for the next three priorities: #2 – Chestermere K-9; #3 Airdrie K-9 (Kings Heights South); #4 Cochrane K-5 (Heartland). 2018-2019 Modular Unit Requests

For its 2018-2019 modular requests to Alberta Education, the Board approved the submission of a request of 23 modular classrooms as follows: four new units at Windsong Heights; six units at Heloise Lorimer; six at East Lake; four at Langdon; and, three at Rainbow Creek. Requests for funding approvals under the Modular Classroom Program must be submitted by Nov. 1, 2017. It is expected that the Province will inform Boards as to their allocation by February 2018. Last year, only 40 modulars were allocated across the entire province.

Alberta Education Consultation

With the expectation that the Government of Alberta is going to table amendments to the School Act sometime during the Fall sitting, Alberta Education hosted an opportunity for trustees, senior staff and parent representatives to provide input into potential areas of changes to the School Act. Greg Luterbach, Darrell Couture, Norma Lang and Fiona Gilbert and a school council parent represented RVS and provided input into

topics that included the Ministry's business plans, school fees, student transportation services and fees, age of access, age of entry, education services agreements with First Nations, and joint use/reserve agreements with municipalities. Watch for updates to be reported when available.
