2. Welcome and Introductions by Aaron
3. Motion for Approval of Agenda by Rhonda, seconded by Liz, all in favour
4. Motion for Approval of May $4 / 17$ Minutes by Ingrid, seconded by Rhonda, all in favour
5. President's Report - Aaron Gertzen
a. Applied for CFEP Grant, requested full $\$ 125,000$ amount, this would give us a minimum of $\$ 250,000$ for late spring or early summer construction
b. RVS is securing proper proposals for playground
i. QUESTION from Fiona - Will community or students be involved. Aaron - Sharon will be offering opportunities to RancheView students and families for feedback, details TBD
c. Vacant Director-at-large position will be up for election at November meeting
6. Funds Raised to Date, Treasurer - Jakki Mackenzie
a. Recent deposit of $\$ 85.53$ for Mabel's Labels
b. Current funds on hand of $\$ 92,802.94$, includes holdings at school account, and also funds in Raffle Account.
c. Four outstanding Six Fabulous Vacations trip winners, have until June 2018 to arrange travel, have all been contacted.
7. Overview of upcoming events - Rochelle Snively
a. Gifts Of Time - Event will be October 25 and 26 during Student Learning Showcases, teachers and staff offer experiences, parents bid for their student. Raised \$1700 last February.
b. Home-Shopping Night - Will be November 16 - Fundraising will have a table, may have raffle or door prize. Will offer table again to School Council no charge.
